## **TOURISM VISA**

### **1. Entry visa application form.**

Application form duly completed and signed (in case of minors, signature of parental authority/legal guardian) and dated. *Link* Application [Ita/Ara](#) o [Eng/Ita](#).

### **2. Recent photos.**

Size 3.5 cm x 4.5 cm, white background, please check the specifications at ICAO. *Link* Requirements photograph ICAO - [Ita](#) / [Eng](#).

### **3. Original Passport** [visit [Extract Article 12 Regulation \(CE\) 810/2009](#)].

Passport valid up to three months after the expiry of the requested visa, issued less than 10 years ago, at least 2 free pages.

### **4. Proof of accommodation in Italy.**

Hotel reservation, other or [declaration of hospitality](#) with a photocopy of Host's Italian passport or Italian ID card.

### **5. Reservation return ticket.**

### **6. Travel Medical insurance .**

Travel medical insurance covering a minimum of 30.000 euro for emergency hospitalization repatriation expenses during the whole stay, valid throughout the Schengen area. [visit [Extract Article 15 Regulation \(CE\) 810/2009](#)].

### **7. The documents which are related to the proof of the social and professional status:**

#### **in case of Employer or trader:**

- a. Registration commercial activity and status of the company,
- b. Last three months of personal and society the bank statement;

#### **in case of an independent / employee:**

- a. Letter from the company in which he/she works to specific the functions performed, the date of employment, social security number, insurance number and injuries,
- b. Salary certificate,
- c. Title holidays,
- d. Personal bank statement for last three months;

#### **in case of free profession :**

- a. The order paper or a business card for current year,
- b. Personal bank statement for last three months;

#### **in case of a student/minors:**

- a. Copy of birth certificate,
- b. Statement of during the applicant's stay is covered by parents or legal guardian,
- c. Supporting social and professional situation and economic means of livelihood of the guarantor,
- d. Authorization of travel for minors should be signed by the parents or legal guardian,
- e. School certificate;

#### **in case a retired or without professional activity:**

- a. Supporting pensions,
- b. Personals bank statement for the last three months,
- c. Certificate of all the expenses are covering by the guarantor, supporting documentation of social and professional status and means economic of subsistence.

Other documents: Real estate certificates, landowners and different income, etc.

**Attention:** to be easy the management file you have to submit all documentation already cited as follows: copy + original in vision, as the order of the list. All documents that in Arabic language should be translated in Italian or English language.
